Waiver of Liability

Permission is granted for Participant to receive emergency medical treatment, if needed. I also agree to indemnify and hold harmless those listed above for all claims arising out of Participant's participation in the Event(s) and all related activities. I agree to let the parties use Participants name and likeness free of charge in any manner and for any purpose without compensation to me or Participant. I understand that this document is intended to be broad and inclusive as permitted by the laws of the state in which the Event(s) is taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver will take place in Chambers County, Texas.

I understand that Extreme Team Sports, their employees, sub-contactors, volunteers, sponsors, and affiliates have the right to remove participants, family, friends or anyone attending an event from games, the league or programs with or without cause and I release and agree not to sue Extreme Team Sports, their employees, sub-contactors, volunteers, sponsors, or their affiliates.
