**Fund Raiser:** All players are required to participate in league fund raiser.

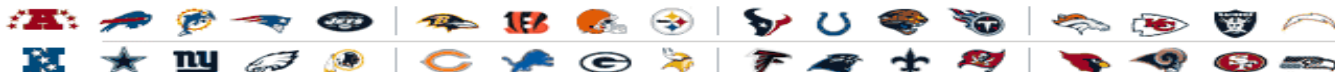
**League Divisions:** 4 & 5 Yr Old - 6-8 Yr Old - 9-11 Yr Old - 12Yr Old.

I understand that this document is intended to be broad and inclusive as permitted by the laws of the state in which the Event(s) is taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver will take place in Chambers County, Texas.
